- (a) Permission for BGE to release up to 24 months of historical electricity and gas usage data for the duration of this agreement.
- (b) Permission for BGE to electronically transfer Customer’s energy usage information at the Address to EPA’s ENERGY STAR Portfolio Manager.
- (c) This authorization commences on the date of execution of this release and terminates the earlier of the date that Customer vacates the Address or at such time as Customer rescinds this authorization by submitting a written notice of rescission to Owner and BGE.
- (d) Permission for the Owner to have access to Customer’s energy usage data through EPA’s ENERGY STAR Portfolio Manager.

### Customer Release

Customer declares that he/she is authorized to execute this release. Customer further certifies that Owner has authority to act on Customer’s behalf to request, from time to time, the disclosure and transmission by BGE to EPA’s ENERGY STAR Portfolio Manager of energy usage associated with Customer at the Address solely to benchmark Owner’s building(s).

Customer releases, holds harmless and indemnifies BGE from any liability, claims, demands, causes of action, damages or expenses resulting from: (i) any release of information or data to EPA for the national energy performance benchmarking program pursuant to this authorization and release; (ii) the unauthorized use of this information or data by EPA; and (iii) any actions taken by EPA with respect to such information or data.
